She will be staying in Mysore for a maximum period i.e., 5 years upto February 2027 or till the declaration of final Ph.D result (Whichever is earlier as per norms of the ICCR Scholarship Scheme). All her living allowances like monthly Stipend @ Rs.22,000/- p.m., Hostel Rent or House Rental allowance (as per actuals or maximum of Rs.5,500/- per month excluding electricity charges, water charges, Wi-Fi., etc.,) and Annual Contingency allowance of Rs.12,500/- (if away from country for more than 6 months only 50% ACA will be paid) besides tuition fees and exam fees (excluding any refundable deposits payable, University Convocation fees, academic transcript fee, document attestation fees, etc.,) are paid by Indian Council for Cultural Relations (ICCR). During Ex-India period student is not entitled for stipend and any other allowances as per the norms of scholarship scheme. Scholar has to purchase annual health medical insurance policy for a minimum sum of Rs.5,00,000/- and the premium for which has to be borne by the scholar himself / herself. The Scholarship will be released to the student through State Bank of India from the date of commencement of course (on receipt of confirmation letter from the International Centre, University of Mysore).

Besides, scholar is also required to pay any additional fees payable to university for having external Research Guide / Research Centre for pursuing her Ph.D Course.

It is herewith requested that he may kindly be issued necessary residential permit at your earliest.
