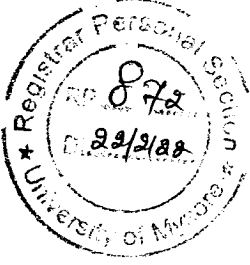

// Sanction Order //

In continuation to the Sanction Order of even number dated 24.08.2020 (copy enclosed), the IFA vide Note 138, dated 10.01.2021 and DG, BPR&D vide Note 139, dated 10.01.2022 (copies enclosed), has approved the sanction for the release of **second instalment of amount of Rs.63,350/- (Rupees Sixty Three Thousand Three Hundred and Fifty Only)** to Shri Pankaj Nain, IPS, OSD, Director, Department of Sports & Youth Affairs, Haryana, for being the Project Coordinator of the research study on "Child Care Institutions under the Juvenile Justice (Care & Protection) Act 2015: Status & Measures to Improve". The Project Director of the research study is Dr. D.C. Nanjunda, Associate Professor cum Dy. Director, Centre for the Study of Social Exclusion and Inclusive Policy, University of Mysore, Karnataka.

2. The total amount sanctioned to the Project Coordinator is Rs.1,90,050/-. The first instalment of Rs.63,350/- was released vide sanction order of even number dated 24.08.2020. The University has submitted the Utilization Certificate and Statement of Expenditure w.r.t. the first instalment and has completed more than 40% of data collection work and the same has been accepted by the DG, BPR&D, thereby fulfilling the condition for release of the second instalment.

3. The remaining amount, i.e., Rs.63,350/- will be released as the final instalment only after satisfactory completion of the project and submission of the project report and receipt of utilization for the full amount of the grant to the BPR&D.

4. The sanction is further subject to the following conditions and its approval by the DG, BPR&D:

- The amount shall be utilised for the purpose for which it has been released.
- The grantee is not permitted to divert the grant for any other purpose. If after, having received the grant, the grantee is not in a position to



- execute or complete the project, the entire amount of the grant received with interest thereupon will be returned forthwith to this Bureau.
- c. Any amount of the grant, which is not spent for the purpose for which it is sanctioned, should be refunded forthwith to this Bureau.
  - d. A receipt of utilization for the full amount of the grant received shall be submitted to this Bureau.
  - e. Forwarding of 10 hard copies of the report along with the soft copy of the report to the BPR&D.
  - f. Forwarding of Executive Summary of the study at the time of submission of the final research study report to the BPR&D.

5. The expenditure would be met from the sanctioned budget grant of BPR&D and is debitable to the following head of account during the financial year 2021-22:
