The Technical Proposal evaluation (Part-I - Presentation) for *Evaluation of Impact of ICDS programme (including Poshan Abhiyan) in Karnataka State in terms of Improving nutritional status of women and children for promoting the achievement of nutritional targets under Sustainable Developmental Goal -2 for the period 2015-16 to 2020-21* of Department of Women & Child Development was held on 11<sup>th</sup> March 2022, accordingly the following 3 COs have made their presentation before the Tender Evaluation Committee as scheduled.

The members of the Tender Evaluation Committee have heard the presentation and verified the supporting documents of the above 3 COs submitted under technical proposal and scored as per RFP tender document:

As per the Clause 5.3 of Data Sheet of Request for Proposal, Consultant Organization should obtain a minimum score to qualify in technical proposal.

*"The minimum technical score required to qualify is 50% in Technical Proposal presentation (Part-I)"*

As per the above clause, all 3 COs are technically qualified. Hence Financial bids of these 3 COs were opened on 14-03-2022 at 11.00 AM through e-Procurement Portal as mentioned in the RFP tender document.

The Financial Bid Opening Committee, KEA has prepared the financial bid evaluation report of the following 3 COs, the financial score was combined with

technical score (Part-I) to generate the total score and finalize the evaluation report. The technical proposals in Part-I for 100 marks is reduced to 70% and the financial bid is reduced to 30% as per sub clause 5.7 of clause 5 of Section-2 of RFP and the COs have been ranked H1, H2 & H3, H1 being the highest.
