### About University of Mysore

The University of Mysore is one of the famous, prestigious and very few oldest universities in India. The University was founded as a result of the efforts made by the benevolent and visionary Maharaja of erstwhile Princely State of Mysore His Highness 'Rajarshi' Shri Nalvadi Krishnaraja Wadiyar -IV (1884-1940) and the then Diwan Sir.M.Vishvesvaraya (1860-1962). Prior to that, all the institutions of Higher Education and Colleges within the Mysore State was under the administration of Madras Presidency and were functioning under Madras University.

Mysore University is the first University in Karnataka State to be accredited by NAAC and has undergone NAAC Accreditation Thrice – First in 2000 with 'Five Star' Status, second time in 2006 with a 'A+' Level and for the Third time in 2012 with a CGPA score of 3.47 on a 4 point scale. NAAC has designated Mysore University as a 'High performing Institution;'. The University Grants Commission has placed Mysore University Under Tier -II Category of Graded Autonomy. Govt. of India has recognized Mysore University as "Institution of Excellence (IOE) in 2008 while the UGC has recognized Mysore University as a University with Potential for Excellence (UPE) in 2009. On the other hand Mysore University is also recognized as a centre with potential for Excellence in a Particular Area (CPEPA). On the recommendations of Karnataka Knowledge commission, the Karnataka government has considered Mysore University as an "Innovative University". Current Science has ranked Mysore University as one of the top 20 Universities Scientific and Research endeavours.


From the four PG Campuses namely Mysore (Manasagangothri), Mandya (Thubinakere), Hassan (Hemagangothri) and Chamarajanagar (Suvarnagangothri) there are 63 PG Departments offering 76 Postgraduate, M.Phil and Ph.D. Programmes. There are 219 affiliated colleges.

### About JSS college of Physiotherapy (JSSCPT),

JSS college of Physiotherapy (JSSCPT), Mysuru, a premier institute with the mandate of carrying out graduate, post-graduate teaching and research in the areas of Physiotherapy was established in 1999 with a goal to create competent physiotherapists having contemporary knowledge & innovative skills to promote rehabilitation, health & fitness. The college has grown in leaps and bounds and now offers BPT with an intake of 60, and Master of Physiotherapy with an intake of 10 under the aegis of Rajiv Gandhi University of Health Sciences. The college employs 16 full time core faculty members and part time faculty in 23 affiliated subjects. These part time faculty members are drawn from our sister institutions that come under the JSS group of educational institutions' banner. The Institute is NAAC accredited with a grade of B+ as a health institute and awarded overall GOLD from QS I-Gauge. Initially housed in a wing of the JSS Hospital, the college moved into its own premises with an area of 2845.05 square metres, in November 2015. With the increase in physical infrastructure, the college has been taking giant strides in its academic and co-curricular activities. The college boasts of well-equipped laboratories for each of the core subjects with optimum facilities in which is a unique feature in our discipline. The college is attached to JSS hospital, a multispecialty hospital with a fully-fledged physiotherapy department and a basic gait lab. An average of 120-150 patients is treated for various physical and functional problems. The college has a decentralized form of administration with division into various departments including academics, supportive, clinical and administrative. Seven departments function in the college namely, Musculoskeletal Sciences, Sports Sciences, Cardio-vascular & Pulmonary Sciences, Paediatrics, Neurological Sciences, Community Health and Movement Science.

The college has an active outreach programme and is deeply committed to improving health education and awareness of disability related issues. Several pioneering initiatives like evaluation tool development, training material and public education material have been developed, compiled and modified by students' and faculty of the college. 
The mission statement of our institution is as follows,

Research findings as a result of this collaborative work of both the parties will be subjected to filing patent and commercialization and technology transfer with respect to Intellectual Property Rights (IPR) in the interest of the researcher, Department of Physical Education, University of Mysore and JSS College of physiotherapy by following Patent & Innovation Policy.
- VI. Cooperation and promotion of education and training in areas of mutual interest
- VII. Any other appropriate mode of interaction agreed upon between JSS COLLEGE OF PHYSIOTHERAPY & UNIVERSITY OF MYSORE, DPE and DOS in PE & SS A Specific plan will be worked out by the Institutes depending upon the availability of resources and as the situation demands.
