


3. The Candidate shall himself/herself bear the cost of Chemical/Stationery and other materials to be used for his/her research work. In case of loss, cost of materials/equipment etc., if any, shall be made good to the Department/ Institution by the candidate.

The Candidate/Researcher/Guide has to follow the terms and conditions of Ph.D Regulations 2017 laid down by University of Mysore in accordance with notification vide reference No.AC2(S)/460/2009-10 dated:20-03-2017 and time to time amendments/modifications shall be adopted after recommendations from the University.

Pursuant to the approval of the Hon'ble Vice-Chancellor, Mr. Chethan V., S/o Venkatesh V. #7C-315 Noormohalla, Kollegal, Karnataka State is awarded the UGC JRF in **PHYSICS** on a Fellowship value of Rs.31,000/- per month initially for a period of two years. he shall work on the research topic "**First Principles Investigation on Physical and Chemical Properties of Some Technologically important Nano Materials**" under the guidance of Dr. Mahendra M, Associate Professor, Department of Studies in Physics, University of Mysore, Manasagangotri, Mysuru.

He is entitled to get an Annual Contingency Grant of Rs.12,000/- as per rules in force. He shall utilize this grant with the prior permission from the Chairman, Department of Studies in Physics, University Of Mysore, Manasagangotri, Mysuru and also on the recommendation of the guide seeking permission for the subsequent occasion. Further, as per rules, he is entitled to draw House Rent Allowance at the rate of 16% of the fellowship amount. He should report himself for duty to the Chairman, Department of Studies in Physics, University Of Mysore, Manasagangotri, Mysuru within a period of one week from the date of receipt of this order, failing which the award will be treated as cancelled.

The tenure of fellowship is initially for two years under the JRF scheme. Upon expiry of this period, the work of the fellow will be evaluated by experts. If the research work is found satisfactory, his tenure will be extended for a further period of three years under the enhanced emoluments of the Senior Research Fellowship (SRF).

In case, the work for the first two years is not found satisfactory, an additional year will be given to him for improvement. However, during this period he will be designated as a Junior Research Fellow. In such case work will be evaluated again after three years, and if improvement is found, the Fellow will get two more years under the SRF. Thus, the total period of fellowship (JRF and SRF) is five years, and there will be no further provision for extension.

The fellowship will be effective from **15-06-2022** or **date of Joining of Ph.D research whichever is later**. He should give a declaration at the time of reporting to duty and the same shall be forwarded to the University.

At the time of joining duty, he is required to produce all the Original Certificates of qualifications, age and date of birth before the Chairman, Department of Studies in Physics, University Of Mysore, Manasagangotri, Mysuru.

Award of this UGC Junior Research Fellowship is subject to the conditions stipulated in the comprehensive ordinance and UGC Guidelines issued from time to time for award of the Research Fellowship. Regarding uploading the documents related to the payment of fellowship, he is directed to approach the ICD Office, Department of Studies in Computer Science, Manasagangotri, Mysuru.
