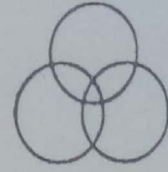

Discipline : Faculty of Arts


Admission procedure: Through University of Mysore Ph. D. Entrance Examination/ UGC-NET/JRF/KSET etc.

The Eligibility: MA in Rural Development / MA in Social Sciences degree from India and abroad.

Entrance Examination: There will be a separate entrance Examination for admission to Ph.D. in Rural Development.

The Research Guide: The Recognized guides of Development studies are eligible to guide Ph.D. Candidates of Rural Development.

The rest of the other rules and regulations remains same as award of Ph. D. in Development Studies for Ph. D. Rural Development and also specified by the UGC and University of Mysore.
