1. Concept level master plan for Amba Township

Amba township is a spiritual township of 100 acres located at Adalaj. The scope of the project includes masterplan development, which includes junction design and pedestrian infrastructure. Neha assisted in preparing drawings showing zonal and schematic masterplan layout.

2. Bhopal bus depot

The project scope includes designing a bus depot for chartered transport in Bhopal. Neha worked on initial planning and BOQ calculations of the bus depot.

3. YMCA junction improvement

This is part of an inhouse research to assess feasibility of junction improvement. Neha conducted site visits and estimated preliminary cost of BOQ along with preparation of presentations

4. Parking Research

The Urban Lab along with UWI are working on research related to parking reforms in Surat and Pune. Neha was involved in generating GIS maps relevant for the study.

5. Right to walk campaign

The Right to Walk campaign is an initiative to push for legislative changes, to exclusively recognize the rights of pedestrians, and to aid in making walking safer through advocacy work. Neha worked on graphic development for social media promotion.

6. Science city street development

The Urban Lab is working on planning and design of the Science city road in Ahmedabad. The project scope includes designing the 3.6 km BRTS corridor along with streetscape, landscaping, intersection design, and infrastructure upgradation. Neha helped in generating few sections for the same.

7. Street development in East Zone, Ahmedabad

The scope of the project is to redevelop the road(2.2km) from Shukan cross road to SP Ring Road. Neha was involved in preparing drawings showing property entrances and footpath details.

8. Nagpur parking study

The scope of the project includes understanding of existing parking condition and calculating the carbon emission for the identified site. Neha worked on street sections and GIS maps related to building use and activity mapping.

9. Preparations of a city logistics plan for Bengaluru

The scope of this project includes understanding freight movement and logistics eco-system in Bengaluru and develop a plan to improve its efficiency. Neha studied few global best practices and activity mapping of freight at the identified sites.

10. Mobility for the Urban Poor

The scope of the project includes understanding the impact of mobility investments on the urban poor. Neha assessed scope of various policies, scheme, missions and the investments related to urban mobility.
