Pursuant to the decision of the Syndicate at its meeting held on 01.02.2022 and approval accorded by the Hon'ble Vice Chancellor dated on 12.11.2022, University of Mysore, Mysuru Dr. Harsha K B is appointed as Assistant Professor on temporary basis in the Mysore University School of Engineering w.e.f 09.11.2022 on the consolidated salary of Rs.55,000/-P.M (Rupees Fifty Five Thousand only) without any usual allowances, for the period of one year.
