S/o Suryanarayana Y.D., # 194, Kadakala Keri Street, Yalanduru Taluk, Chamarajanagar District -571 441, Karnataka is awarded the National Fellowship and Scholarship for Higher Education of ST Students for the year 2022-23 in Humanities & Social Sciences. The National Fellowship for Higher Education is tenable for five years subject to the satisfactory progress report of the fellow. He is eligible to draw Rs. 31,000/- First 2 Years and Rs. 35,000/- remaining 3 Years per month. He shall work on the research topic "CHANGE AND DEVELOPMENT AMONG THE HASALARU COMMUNITY IN CHIKKAMAGALURU DISTRICT, KARNATAKA" under the guidance of Prof. M.R. Gangadhar, Professor, DOS in Anthropology, Manasagangotri, Mysuru.

He is entitled to an Annual Contingency Grant of Rs. 20,500/- per annum as per rules in force. He shall utilize the grant with the prior permission from the Chairman, DOS in Anthropology, Manasagangotri, Mysuru and also on the recommendation of the guide on each occasion, and he shall furnish the details of amounts drawn during previous occasions while seeking permission for the subsequent occasion. Further as per rules, he entitled to draw House Rent Allowance at the rate of 16% of the fellowship amount.


He should report himself for duty to the Chairman, DOS in Anthropology, Manasagangotri, Mysuru within a period of one week from the date of receipt of this order, failing which the award will be treated as cancelled and disposed of otherwise. The fellowship will be effect from 01.04.2022 or from the date of registration under Ph.D. or from the date of joining in Ph.D. Programme, whichever is later.

The fellowship is tenable for five years subject to satisfactory progress report of the fellow or submission of Ph.D. thesis whichever is earlier. He should give a declaration at the time of reporting to duty and the same shall be forwarded to the University.

At the time of joining duty, he is required to produce all the original certificates of qualifications, age and date of birth before **Chairman**, **DOS** in **Anthropology**, **Manasagangotri**, **Mysuru** for verification and return. Award of the National Fellowship and Scholarship for Higher Education of ST student is subject to the conditions stipulated in the Comprehensive Ordinance and Ministry of Tribal affairs guidelines issued from time to time for award of the National Fellowship and Scholarship for Higher Education of ST student.

The fellowship will be paid up to a maximum period of five years or the date of submission of dissertation, whichever is earlier. Further, the payment of fellowship shall be regulated in accordance with para 5.4.1 of the guidelines.
- 3. The provisional selection is subject to the condition that the awardee has already joined regular and full time Ph.D. course in a University/Institution covered under

the Scheme Guidelines as mentioned in Para no. 2.4, while applying for the fellowship, and other conditions of the scheme and stipulations mentioned in this letter.

- 4. The awardee is required to produce original certificates including Bank Pass book to the respective University/Institute for verification and linking at <a href="https://scholarship.canarabank.in">https://scholarship.canarabank.in</a>. The linking process should be completed on or before 31st July 2023 by the concerned university/Institute. Failure to link in the Canara Bank portal before the specified timeline will render this award cancelled. The awardee's Bank Account should be Aadhaar linked, Email id, phone number and Bank Account number of awardees should remain unchanged during the entire period of fellowship.
