Pursuant to the approval of the Vice-Chancellor, **Mr. Mr. Praveen R.S/o Raju, # 02, Kollegala, Chamarajanagar District -571 440, Karnataka** is awarded the National Fellowship and Scholarship for Higher Education of ST Students for the year **2021-22** in **Humanities & Social Sciences**. The National Fellowship for Higher Education is tenable for five years subject to the satisfactory progress report of the fellow. He is eligible to draw **Rs. 28,000/-** (From 01.04.2021 to 31.03.2022), (**From 01.04.2022 onwards Rs. 31,000 pm First 2 Years and Rs. 35,000 pm remaining 3 Years**) per month. He shall work on the research topic "**ATTENUATION OF PANCREATITIS BY ENZYME INHIBITORS IN ANIMAL MODEL**" under the guidance of **Prof. B.S. Vishwanath, Professor, DOS in Biochemistry, Manasagangotri, Mysuru.**

He is entitled to an Annual Contingency Grant of **Rs. 20,500/-** per annum as per rules in force. He shall utilize the grant with the prior permission from the **Chairman, DOS in Biochemistry, Manasagangotri, Mysuru** and also on the recommendation of the guide on each occasion, and he shall furnish the details of amounts drawn during previous occasions while seeking permission for the subsequent occasion. Further as per rules, he entitled to draw House Rent Allowance at the rate of 16% of the fellowship amount.

He should report himself for duty to the **Chairman, DOS in Biochemistry, Manasagangotri, Mysuru** within a period of one week from the date of receipt of this order, failing which the award will be treated as cancelled and disposed of otherwise. **The fellowship will be effect from 2021-22 or from the date of registration under Ph.D. or from the date of joining in Ph.D. Programme, whichever is later.**

The fellowship is tenable for five years subject to satisfactory progress report of the fellow or submission of Ph.D. thesis whichever is earlier. He should give a declaration at the time of reporting to duty and the same shall be forwarded to the University.

At the time of joining duty, he is required to produce all the original certificates of qualifications, age and date of birth before **Chairman, DOS in Biochemistry, Manasagangotri, Mysuru** for verification and return. Award of the National Fellowship and Scholarship for Higher Education of ST student is subject to the conditions stipulated in the Comprehensive Ordinance and Ministry of Tribal affairs guidelines issued from time to time for award of the National Fellowship and Scholarship for Higher Education of ST student.

Regarding payment of fellowship amount the awardee is required to follow the instructions given in the award letter.



Note:

First two years of the course, the enhanced fellowship rate @ Rs.31,000/- per month and for remaining three years of the course, the enhanced fellowship rate @ Rs.35,000/- per month will be effective from 1.4.2022.

2. The fellowship will commence from 1.4.2021 for the selection year 2021-22 based on the joining date. The course duration will be reckoned from the commencement of the course irrespective of the selection year. The fellow will be paid fellowship amount up to the period of five years or the date of submission of dissertation, whichever is earlier.


5. The award is liable to be cancelled and appropriate legal action will be taken against the awardee in the following cases: -
