I am pleased to inform you that based on your qualifying for Eligibility for Assistant Professor in the **UGC-NET December 2022**, you have been selected for award of fellowship under the scheme of National Fellowship for Scheduled Caste Students (NFSC).

The tenure of the Fellowship is five years and it commences from the date of declaration of result for NFSC, i.e., **13-Apr-2023** (or) from the date of admission under M.Phil/Ph.D (or) from the date of joining M.Phil/Ph.D programme, whichever is later.

As per information provided by you while applying online for UGC-NET, you had already taken admission for M.Phil/Ph.D through regular and full time mode in a UGC recognized University / Institution. Accordingly, you are required to apply for fellowship not later than three months from the date of issue of this award letter. The University/Institution is requested to process for award of fellowship based upon this letter, in accordance with the Guidelines of National Fellowship for Scheduled Caste Students available at <https://socialjustice.gov.in/> & <https://www.nsfdc.nic.in/>

It may be noted that the fellowship amount shall be disbursed through Canara Bank to bank account of the awardee (any bank) directly. Initially, the awardee is to register at Scholar's Corner available at Scholarship & Fellowship Management Portal (SFMP) (<https://scholarship.canarabank.in/>). The Universities / Institutions will link the data of the awardee with the Master Data on the SFMP with their unique Maker and Checker IDs. The Universities/Institutions shall update the information on the master data (regarding monthly payment confirmation, HRA, up-gradation, resignation etc.) of the awardee on monthly basis. Based on the data updated on SFMP by the concerned Universities / Institutions, the payment of the fellowship will be made to the awardee.

The e-Certificate of Eligibility for Assistant Professor has already been uploaded on <https://ugcnet.nta.nic.in>. The eligibility of the candidate for availing the fellowship is to be ensured by the University/Institution.

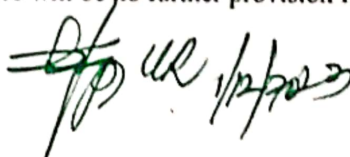
Pursuant to the approval of the Hon'ble Vice-Chancellor, Smt.Nandini.D D/o Dharmappa S.K, No.51, Lakshmi Hayagreeva, 7<sup>th</sup> Cross, Aishwarya Royal Layout, Rajarajeshwari Nagara, Mysuru, Karnataka-570 022, is awarded the National Fellowship for Scheduled Caste in **Computer Science and Application** on a Fellowship value of Rs.42,000/- per month initially for a period of two years. She shall work on the research topic **"ARTIFICIAL INTELLIGENCE IN QUALITY EVALUATION OF FOOD PRODUCTS"** under the guidance of Prof.Guru D.S., Professor, Department of Studies in Computer Science, Manasagangotri, Mysuru.

She is entitled to get an Annual Contingency Grant of Rs.12,000/- as per rules in force. She shall utilize this grant with the prior permission from the Chairman, Department of Studies in Computer Science, Manasagangotri, Mysuru and also on the recommendation of the guide seeking permission for the subsequent occasion. Further, as per rules, she is entitled to draw House Rent Allowance at the rate of 18% of the fellowship amount. She should report herself for duty to the Chairman, D.O.S in Computer Science, Manasagangotri, Mysuru within a period of one week from the date of receipt of this order, failing which the award will be treated as cancelled.

The tenure of fellowship is five years, but as per the reference cited (3) above, the candidate has availed SC/ST Fellowship from the University of Mysore for Nine months, hence, the tenure of the fellowship is for four years and three months only.

On completion of two years research, the work of the fellow will be evaluated by experts. If the research work is found satisfactory, her tenure will be extended for a further remaining period under the enhanced emoluments of the Senior Research Fellowship (SRF).

In case, the work for the first two years is not found satisfactory, an additional year will be given to her for improvement. However, during this period she will be designated as a Junior Research Fellow. In such case, work will be evaluated again after three years, and if improvement is found, the Fellow will get remaining period under the SRF. Thus, the total period of fellowship (JRF and SRF) is five years, (counting the period of fellowships obtained from the University of Mysore,) and there will be no further provision for extension.

The fellowship will be effective from 13-04-2023 or date of Joining of Ph.D research whichever is later. She should give a declaration at the time of reporting to duty and the same shall be forwarded to the University.

At the time of joining duty, she is required to produce all the Original Certificates of qualifications, age and date of birth before the Chairman, DOS in Computer Science, University of Mysore, Mysuru, for verification and return.

Award of this National Fellowship for SC is subject to the conditions stipulated in the Comprehensive Ordinance and UGC Guidelines issued from time to time for award of the Research Fellowship. Regarding uploading the documents related to the payment of fellowship, she is directed to approach the ICD Office, Department of Studies in Computer Science, Manasagangothri, Mysuru and also follow the instructions given in the award letter.
