The fellowship would be effective from 1st April of the selection year (2022-23) or the actual date of joining under the fellowship in the University/College/Institution, whichever is later. The total tenure of the fellowship is 5 years.

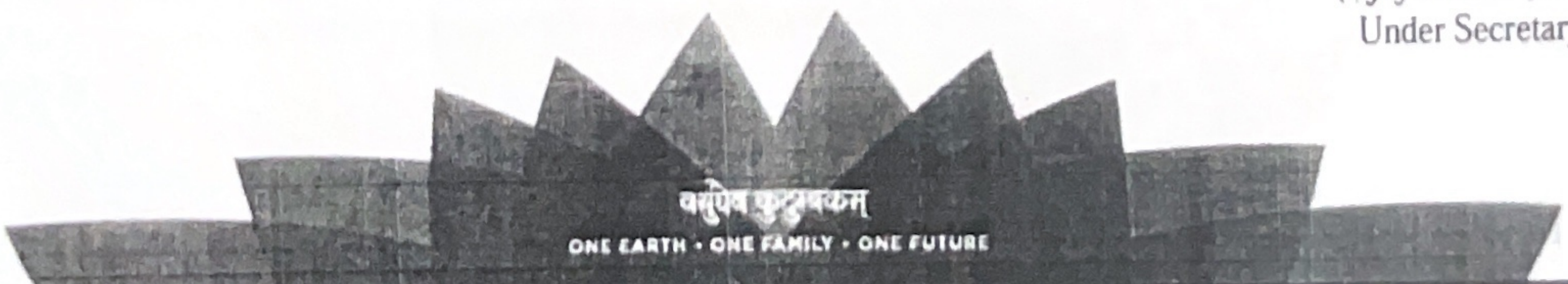

Pursuant to the approval of the Hon'ble Vice-Chancellor, Ms. Nethravathi P., D/o Paramesh V, No. 592/540/1, Damodara Badavane, Alanahalli Grama Panchayat, Near Mega Milk Dairy, Alanahalli, Mysore Karnataka State is awarded the **Savitribai Jyotirao Phule Single Girl Child Fellowship in Economics** on a Fellowship value of Rs.31,000/- per month initially for a period of two years. She shall work on the research topic "**DETERMINANTS AND COMPOSITION OF RURAL HOUSEHOLD SAVINGS – A STUDY IN KARNATAKA STATE**" under the guidance of Prof. D.V.Gopalappa, Professor, Department of Studies in Economics and Cooperation, University of Mysore, Manasagangotri, Mysuru.

She is entitled to get an Annual Contingency Grant of Rs.10,000/- as per rules in force. She shall utilize this grant with the prior permission from the Chairman, Department of Studies in Economics and Co-operation, University Of Mysore, Manasagangotri, Mysuru and also on the recommendation of the guide seeking permission for the subsequent occasion. Further, as per rules, she is entitled to draw House Rent Allowance at the rate of 16% of the fellowship amount. She should report himself for duty to the Chairman, Department of Studies in Economics and Co-operation, University Of Mysore, Manasagangotri, Mysuru.

The tenure of fellowship is initially for two years under the JRF scheme. Upon expiry of this period, the work of the fellow will be evaluated by experts. If the research work is found satisfactory, her tenure will be extended for a further period of three years under the enhanced emoluments of the Senior Research Fellowship (SRF).

In case, the work for the first two years is not found satisfactory, an additional year will be given to her for improvement. However, during this period she will be designated as a Junior Research Fellow. In such case work will be evaluated again after three years, and if improvement is found, the Fellow will get two more years under the SRF. Thus, the total period of fellowship (JRF and SRF) is five years, and there will be no further provision for extension.

The fellowship will be effective from **01-04-2022** or **date of Joining of Ph.D research whichever is later**. She should give a declaration at the time of reporting to duty and the same shall be forwarded to the University.

At the time of joining duty, she is required to produce all the Original Certificates of qualifications, age and date of birth before the Chairman, Department of Studies in Economics and Co-operation, University Of Mysore, Manasagangotri, Mysuru.

Award of this UGC Junior Research Fellowship is subject to the conditions stipulated in the Comprehensive Ordinance and UGC Guidelines issued from time to time for award of the Research Fellowship. Regarding uploading the documents related to the payment of fellowship, she is directed to approach the ICD Office, Department of Studies in Computer Science, Manasagangotri, Mysuru.



1. The Doctoral Candidates should conduct research for a minimum period of 03 years and maximum period of 6 years from the date of provisional registration as per the 8.1(a) Ph.D Regulation 2017.
2. The Ph.D registration is valid for a period of 6 years from the date of provisional registration and it is extendable by one more year on request by the candidate well in advance with a recommendation of the Guide and Director/Chairperson of the Institute/Department followed by approval of Vice-Chancellor on payment of the prescribed fee.
3. The candidate should submit progress reports certified by the Guide and Director/Chairperson of the Institute/ Department with the fee paid challan in every year. If the candidate fails to submit two Consecutive Progress Reports in time, it amounts to cancellation of the Registration, and this shall be notified by the Registrar(Evaluation). For any reason the fee paid, will not be reimbursed to the researcher.
4. While submitting the progress report Tuition fee, Processing fee and Laboratory fee has to be paid to the Examination Account and the Challan should be enclosed.
5. Examination fee has to be paid to the Examination Account of the University
6. y and the Challan has to be furnished at the time of submission of Final Synopsis and Thesis.
7. The Research candidate shall strictly adhere to the Regulation mentioned above.
8. On completion of research work, 10 copies of synopsis and 4 copies of thesis, an electronic version of the thesis, evidence of two research publications, prescribed application form for submission of thesis and synopsis, challan for having paid the examination fee, declaration signed by the candidate and certified by the guide for having prepared the thesis, No Due Certificates from the Department, Library and the Hostel should be submitted through the guide and the Director/Chairperson of the Institution/Department. Details of payable fee can be obtained from the Office of the Directorate of Research, Pareeksha Bhavan, University of Mysore, Mysuru, during office hours.
9. If candidate fails to submit the thesis even after 7 years i.e after getting one year of extension period, the Ph.D registration in the respective subject stands automatically cancelled.
