
1. The Candidate has to undergo a Ph.D Course work of one semester of 20 weeks as per rule 6.1 and 6.2 of Ph.D. Regulations 2017. After successful completion of the course work and Pre-registration colloquium as per 6.1 to 6.4 & 7.1 the candidate is eligible to submit the progress report and to apply for Permanent Registration as per rule 6:6 to the Office of Directorate of Research, University of Mysore, within 06 months from the date of announcement of the course work result by Registrar(Evaluation). If not, the candidate forfeits his/her claims for Registration (6.7) & the Pre-Registration stands cancelled and the candidate should go through entrance test afresh.
2. The Candidate has to pay tuition fee, candidature fee, laboratory fee and other fee as applicable. Details about fee structure can be obtained from the office of Directorate of Research, University of Mysore, Mysuru.
3. The Candidate shall himself/herself bear the cost of Chemical/Stationery and other materials to be used for his/her research work. In case of loss, cost of materials/equipment etc., if any, shall be made good to the Department/ Institution by the candidate.

Pursuant to the approval of the Hon'ble Vice-Chancellor, Mr. Akash. R., S/o Rajiv Patil. K.N., C/o Maruthi. G, Forest Department, Kuvempu Badavane, 4th Cross, KRS Road, Ilavala, Mysore Karnataka State is awarded the UGC JRF in **Geography** on a Fellowship value of Rs.31,000/- per month initially for a period of two years. He shall work on the research topic "**GENDER STUDIES**" under the guidance of Dr. Chandrashekar. B., Professor, Department of Studies in Geography, University of Mysore, Manasagangotri, Mysuru.

He is entitled to get an Annual Contingency Grant of Rs.10,000/- as per rules in force. He shall utilize this grant with the prior permission from the Chairman, Department of Studies in Geography, University of Mysore, Manasagangotri, Mysuru and also on the recommendation of the guide seeking permission for the subsequent occasion. Further, as per rules, he is entitled to draw House Rent Allowance at the rate of 16% of the fellowship amount. He should report himself for duty to the Chairman, Department of Studies in Geography, University of Mysore, Manasagangotri, Mysuru.

The tenure of fellowship is initially for two years under the JRF scheme. Upon expiry of this period, the work of the fellow will be evaluated by experts. If the research work is found satisfactory, his tenure will be extended for a further period of three years under the enhanced emoluments of the Senior Research Fellowship (SRF).

In case, the work for the first two years is not found satisfactory, an additional year will be given to him for improvement. However, during this period he will be designated as a Junior Research Fellow. In such case work will be evaluated again after three years, and if improvement is found, the Fellow will get two more years under the SRF. Thus, the total period of fellowship (JRF and SRF) is five years, and there will be no further provision for extension.

The fellowship will be effective from 16-12-2022 or **date of Joining of Ph.D research whichever is later**. He should give a declaration at the time of reporting to duty and the same shall be forwarded to the University.

At the time of joining duty, he is required to produce all the Original Certificates of qualifications, age and date of birth before the Chairman, Department of Studies in Geography, University of Mysore, Manasagangotri, Mysuru.

Award of this UGC Junior Research Fellowship is subject to the conditions stipulated in the comprehensive ordinance and UGC Guidelines issued from time to time for award of the Research Fellowship. Regarding uploading the documents related to the payment of fellowship, he is directed to approach the ICD Office, Department of Studies in Computer Science, Manasagangotri, Mysuru.
