Pursuant to the approval of the Vice-Chancellor Ms. Mahadevamma M D/o Marinnanjaiah, # 01, Ambedkar Street, Mangala Village, Hanur Hobli, Kollegal Taluk, Chamarajanagar District, Karnataka- 571 443, is awarded the National Fellowship for SC Candidate (CSIR-UGC Test) for the year 2021-22 in Kannada. The National Fellowship for SC is tenable for five years subject to the satisfactory progress report of the fellow. She is eligible to draw Rs. 31,000/- per month for first two years and Rs. 35,000/- per month for next three years. She shall work on the research topic "HANURU TALUKINA BUDAKATTU JANAPADA VAIDYA PADDATHI" under the guidance of Prof. Nanjaiah Honganur, Professor, Kuvempu Institute of Kannada Studies, Manasagangotri, Mysuru, She is entitled to an Annual Contingency Grant of Rs. 10,000/- per annum for initial two years and Rs. 20,500/- per annum for remaining three years as per rules in force. She shall utilize the grant with the prior permission from the Director, Kuvempu Institute of Kannada Studies, Manasagangotri, Mysuru and also on the recommendation of the guide on each occasion and he shall furnish the details of amounts drawn during previous occasions while seeking permission for the subsequent occasion. Further as per rules he entitled to draw House Rent Allowance at the rate of 16% of the fellowship amount.

She should report herself for duty to the Director, Kuvempu Institute of Kannada Studies, Manasagangotri, Mysuru within a period of one week from the date of receipt of this order, failing which the award will be treated as cancelled and disposed of otherwise. The fellowship will be effect from 05.11.2022 or the date of joining whichever is later.

The fellowship is tenable for five years subject to satisfactory progress report of the fellow or submission of Ph.D. thesis whichever is earlier,

She should give a declaration at the time of reporting to duty and the same shall be forwarded to the University.

At the time of joining duty, she is required to produce all the original certificates of qualifications, age and date of birth before **Director, Kuvempu Institute of Kannada Studies, Manasagangotri, Mysuru** for verification and return, and award of the National Fellowship for SC is subject to the conditions stipulated in the Comprehensive Ordinance and UGC guidelines issued from time to time for award of the Fellowship.

Regarding Payment of fellowship amount the awardee is required to follow the instructions given in the award letter.

I am pleased to inform you that based on your qualifying for Eligibility for Assistant Professor in the **December 2021 & June 2022 (merged session) National Eligibility Test (UGC-NET)**, you have been selected for award of fellowship under the scheme of National Fellowship for Scheduled Caste Students (NFSC).

The tenure of the Fellowship is five years and it commences from the date of declaration of result for NFSC, i.e., **05-Nov-2022** (or) from the date of admission under M.Phil/Ph.D (or) from the date of joining M.Phil/Ph.D programme, whichever is later.

As per information provided by you while applying online for UGC-NET, you have not taken admission for M.Phil/Ph.D. Accordingly, you are required to get admission and registration for regular and fulltime M.Phil/Ph.D course in a University / Institutions recognized by UGC at the first available opportunity but not later than three years from the date of issue of this award letter. The University/Institution is requested to process for award of fellowship based upon this letter, in accordance with the Guidelines of National Fellowship for Scheduled Caste Students available at <https://socialjustice.gov.in/> & <https://www.nsfdc.nic.in/>

It may be noted that the fellowship amount shall be disbursed through Canara Bank to bank account of the awardee (any bank) directly. Initially, the awardee is to register at Scholar's Corner available at Scholarship & Fellowship Management Portal (SFMP) (<https://scholarship.canarabank.in/>). The Universities / Institutions will link the data of the awardee with the Master Data on the SFMP with their unique Maker and Checker IDs. The Universities/Institutions shall update the information on the master data (regarding monthly payment confirmation, HRA, up-gradation, resignation etc.) of the awardee on monthly basis. Based on the data updated on SFMP by the concerned Universities / Institutions, the payment of the fellowship will be made to the awardee.

The e-Certificate of Eligibility for Assistant Professor has already been uploaded on <https://ugcnet.nta.nic.in>. The eligibility of the candidate for availing the fellowship is to be ensured by the University/Institution.
