

Hence, the following order.

Pursuant to the approval of the Hon'ble Vice-Chancellor, Mr. Nagesha K.B., UGC-Junior Research Fellow, Kuvempu Institute of Kannada Studies, University of Mysore, Mysuru, is designated as Senior Research Fellow with an enhanced fellowship of Rs.35,000/- per month from 20-11-2020 to 19-11-2023 or submission of thesis whichever is earlier and admissible HRA as per rules and contingency grant of Rs.20,500/- per annum to be utilized with the permission of the Director, Kuvempu Institute of Kannada Studies, University of Mysore, Mysuru. The overall fellowship including JRF and SRF are tenable only for a maximum period of five years.
