The National Fellowship for Higher Education is tenable for five years subject to the satisfactory progress report of the fellow. She is eligible to draw Rs. 28,000/- (From 01.04.2021 to 31.03.2022), (From 01.04.2022 onwards Rs. 31,000 pm First 2 Years and Rs. 35,000 pm remaining 3 Years) per month. She shall work on the research topic "DEVELOPMENT AND STANDARDIZATION OF WELL-BEING SCALE IN INDIAN CONTEXT" under the guidance of Prof. Sampathkumar, Professor, DOS in Psychology, Manasagangotri, Mysuru.

She is entitled to an Annual Contingency Grant of Rs. 20,500/- per annum as per rules in force. She shall utilize the grant with the prior permission from the Chairman, DOS in Psychology, Manasagangotri, Mysuru and also on the recommendation of the guide on each occasion, and she shall furnish the details of amounts drawn during previous occasions while seeking permission for the subsequent occasion. Further as per rules, she entitled to draw House Rent Allowance at the rate of 16% of the fellowship amount.

She should report herself for duty to the Chairman, DOS in Psychology, Manasagangotri, Mysuru within a period of one week from the date of receipt of this order, failing which the award will be treated as cancelled and disposed of otherwise. The fellowship will be effect from 2021-22 or from the date of registration under Ph.D. or from the date of joining in Ph.D. Programme, whichever is later.

The fellowship is tenable for five years subject to satisfactory progress report of the fellow or submission of Ph.D. thesis whichever is earlier. She should give a declaration at the time of reporting to duty and the same shall be forwarded to the University.

At the time of joining duty, she is required to produce all the original certificates of qualifications, age and date of birth before Chairman, DOS in Psychology, Manasagangotri, Mysuru for verification and return.
