Pursuant to the approval of the Vice-Chancellor, Ms. Sangeetha R. D/o Ramachandra R, # 401, 2nd Cross, Gayathripuram, 2nd Stage, Udayagiri Post, Mysore -560 019, Karnataka is awarded the National Fellowship and Scholarship for Higher Education of ST Students for the year 2021-22 in Humanities and Social Sciences. The National Fellowship for Higher Education is tenable for five years subject to the satisfactory progress report of the fellow. She is eligible to draw Rs. 31,000/- First 2 Years and Rs. 35,000 pm remaining 3 Years per month. She shall work on the research topic "ACADEMIC LEARNING OF RURAL STUDENT AND COVID-19 A- SOCIOLOGICAL STUDY" under the guidance of Dr. S. Yashoda, Professor, DOS in Sociology, Manasagangotri, Mysuru.

She is entitled to an Annual Contingency Grant of Rs. 20,500/- per annum as per rules in force. She shall utilize the grant with the prior permission from the Chairman, DOS in Sociology, Manasagangotri, Mysuru and also on the recommendation of the guide on each occasion, and she shall furnish the details of amounts drawn during previous occasions while seeking permission for the subsequent occasion. Further as per rules, she entitled to draw House Rent Allowance at the rate of 16% of the fellowship amount.

She should report herself for duty to the Chairman, DOS in Sociology, Manasagangotri, Mysuru within a period of one week from the date of receipt of this order, failing which the award will be treated as cancelled and disposed of otherwise. The fellowship will be effect from 2021-22 or from the date of registration under Ph.D. or from the date of joining in Ph.D. Programme, whichever is later.

The fellowship is tenable for five years subject to satisfactory progress report of the fellow or submission of Ph.D. thesis whichever is earlier. She should give a declaration at the time of reporting to duty and the same shall be forwarded to the University.

At the time of joining duty, she is required to produce all the original certificates of qualifications, age and date of birth before Chairman, DOS in Sociology, Manasagangotri, Mysuru for verification and return. Award of the National Fellowship and Scholarship for Higher Education of ST student is subject to the conditions stipulated in the Comprehensive Ordinance and Ministry of Tribal affairs guidelines issued from time to time for award of the National Fellowship and Scholarship for Higher Education of ST student.

The provisional selection is subject to the condition that the awardee has already joined regular and full time Ph.D course in a University/Institution covered under the Scheme Guidelines as mentioned in Para no. 2.4, while applying for the fellowship, and other conditions of the scheme and stipulations mentioned in this letter.
- 4.
