Pursuant to the approval of the Vice-Chancellor, **Ms. Sangeetha R. D/o Ramachandra R, # 401, 2<sup>nd</sup> Cross, Gayathripuram, 2<sup>nd</sup> Stage, Udayagiri Post, Mysore -560 019, Karnataka** is awarded the National Fellowship and Scholarship for Higher Education of ST Students for the year **2021-22 in Humanities and Social Sciences**. The National Fellowship for Higher Education is tenable for five years subject to the satisfactory progress report of the fellow. She is eligible to draw Rs. 31,000/- First 2 Years and Rs. 35,000 pm remaining 3 Years per month. She shall work on the research topic "**ACADEMIC LEARNING OF RURAL STUDENT AND COVID-19 A- SOCIOLOGICAL STUDY**" under the guidance of **Dr. S. Yashoda, Professor, DOS in Sociology, Manasagangotri, Mysuru.**

She is entitled to an Annual Contingency Grant of **Rs. 20,500/-** per annum as per rules in force. She shall utilize the grant with the prior permission from the **Chairman, DOS in Sociology, Manasagangotri, Mysuru** and also on the recommendation of the guide on each occasion, and she shall furnish the details of amounts drawn during previous occasions while seeking permission for the subsequent occasion. Further as per rules, she entitled to draw House Rent Allowance at the rate of 16% of the fellowship amount.

She should report herself for duty to the **Chairman, DOS in Sociology, Manasagangotri, Mysuru** within a period of one week from the date of receipt of this order, failing which the award will be treated as cancelled and disposed of otherwise. **The fellowship will be effect from 2021-22 or from the date of registration under Ph.D. or from the date of joining in Ph.D. Programme, whichever is later.**

The fellowship is tenable for five years subject to satisfactory progress report of the fellow or submission of Ph.D. thesis whichever is earlier. She should give a declaration at the time of reporting to duty and the same shall be forwarded to the University.

At the time of joining duty, she is required to produce all the original certificates of qualifications, age and date of birth before **Chairman, DOS in Sociology, Manasagangotri, Mysuru** for verification and return. Award of the National Fellowship and Scholarship for Higher Education of ST student is subject to the conditions stipulated in the Comprehensive Ordinance and Ministry of Tribal affairs guidelines issued from time to time for award of the National Fellowship and Scholarship for Higher Education of ST student.

Regarding payment of fellowship amount the awardee is required to follow the instructions given in the award letter.





Note:

First two years of the course, the enhanced fellowship rate @ Rs.31,000/- per month and for remaining three years of the course, the enhanced fellowship rate @ Rs.35,000/- per month will be effective from 1.4.2022.

2. The fellowship will commence from 1.4.2021 for the selection year 2021-22 based on the joining date. The course duration will be reckoned from the commencement of the course irrespective of the selection year. The fellow will be

paid fellowship amount up to the period of five years or the date of submission of dissertation, whichever is earlier.

3. The provisional selection is subject to the condition that the awardee has already joined regular and full time Ph.D course in a University/Institution covered under the Scheme Guidelines as mentioned in Para no. 2.4, while applying for the fellowship, and other conditions of the scheme and stipulations mentioned in this letter.

4. The awardee is required to produce Original Certificates including Bank Pass book of the awardee for verification and linking at <https://scholarship.canarabank.in> by the concerned university/Institute on or before 14<sup>th</sup> November 2022. Bank Account should be Aadhar linked. Your email id, phone number and Bank Account number should remain unchanged during the entire period of fellowship.

5. The award is liable to be cancelled and appropriate legal action will be taken against the awardee in the following cases: -

- a. If the awardee is found to be ineligible to receive the award, at any point of time during the entire duration of the fellowship.
- b. Misconduct.
- c. Unsatisfactory progress of research work.
- d. Fellowship/Scholarship was availed for the same/similar course from this Ministry on earlier occasion.
- e. Availing Fellowship/Scholarship from other Schemes of this Ministry or from any other source.
- f. Concealment of facts/material document.
