SUMMARY TERMS AND CONDITIONS

- 1. Some of the essential conditions/rules of Emeritus Scientistship (ES) are given below for your notice: (a) (i) The ES scheme is initially sanctioned for three (3) years and if recommended for extension by the committee, extended by two more years after an application is made in form E and forwarded through host Institution. It should be applicable only upto 65 years of age. In case the ES ship was awarded at a stage when the ES was over 62 years of age, the exact duration of the award would be computed upto his/her attaining 65 years of age and it would be so stated in the sanction.
 - (ii) In the case of SSB Awardees, Fellows of INSA, IAS, NASI and INAE, the Emeritus Scientist Ship will be admissible for a period of 5 years, subject to condition that (i) The term of ES does not go beyond 70 years of age and, (ii) There is a favourable recommendation from the Director of Laboratory or Vice-Chancellor of
- (b) The progress reports will be reviewed twice, once after two-and-a-half years, so that the decision to extend or not beyond the initial three years period upto attaining of 65 years of age of ES could be taken in time, and finally
- (c) The Emeritus Scientistship will be valid for one year from the date of offer, or from the date of superannuation, and if the Emeritus Scientist does not join within a year, it must be deemed cancelled and withdrawn. The date of commencement of the scheme will be from the date ES starts drawing scientist allowance.
- (d) If an Emeritus Scientist accepts any other fellowship or assignment, honorarium or employment, his sanction will be deemed withdrawn. No lien will be allowed. The scientist could apply again, if he wishes to pursue research at a later stage, after his tenure with pay etc. is over, subject to other conditions of age etc.

The first installment of the grants will be released on submission of the following documents/information

- (a) Acceptance of the grants sanctioned and the claim bill (in triplicate), specimen enclosed herewith, Claim bills have to be countersigned by authorized signatories (Registrar, Vice Chancellor, Finance Officer etc.)
- (b) An Undertaking in the prescribed Form-A (Available on website www.csirhrdg.res.in) executed on non-judicial stamp paper of Rs. 10/-, each page duly signed.
- (c) A certificate by you countersigned by the Head of the Department/Head of the Institution that no other aid-giving agency is funding your sanctioned scheme.
- (d): RBI-EFT Form (Form-K)

Research Grant will include contingency & minor equipment etc. "Staff Stipend" will be utilized from the date the Research Fellow/Associate joins duty in accordance with the rules stipulated in the terms and conditions and he/she will be paid stipend after receipt of approval of appointment from CSIR.

While claiming grants for the subsequent year/period the position regarding unspent balances of the previous year's grants must be mentioned head-wise in the bill failing which the same may be returned unpassed for compliance. Statement of accounts and Utilization Certificate duly audited by the Accounts Officer and countersigned by the next higher authority in respect of the grants received and expenditure incurred with balance, if any, during the previous year should also be invariably enclosed with the bill.

Utilization of funds and maintenance of accounts under the head "Staff" "Research Grant" & "Equipment" and appointment of Research Fellows/Associates should be in accordance with the procedure laid down in the terms and
