After successful completion of the course work and Pre-registration colloquium as per 6.1 to 6.4 & 7.1 the candidate is eligible to submit the progress report and to apply for Permanent Registration as per rule 6.6 to the Director of Research, UOM within 6 months from the date of successful completion of the course work. If not, the candidate forfeits claims for Registration (6.7) & the Pre-Registration stands cancelled and the candidate should go through entrance test afresh.




- 1) The Doctoral Candidates should conduct research for a minimum period of 30 months from the date of registration.
- 2) The registration is valid for a period of 5 years from the date of registration and it is extendable by two more years on request by the candidate well in time before it expires with specific recommendation of the Guide and the approval of the Vice Chancellor and on payment of the prescribed fee.
- 3) The candidate should submit progress reports certified by the Guide and Head of the Department with the fee paid challan in every year. If the candidate is failed to submit two Consecutive Research Progress Reports shall entail cancellation of the Registration, and this shall be notified by the Registrar(Evaluation). For any reason the fee paid, will not be reimbursed to the scholar.
- 4) As per Ph.D Regulation-2010(After Amendment) and the Syndicate decision, dated: 19-06-2015, subject to the submission of Ph.D Entrance examination certificate and Course work examination certificate, the candidate is eligible for pre-thesis colloquium and final submission. Those who have qualified in Ph.D Entrance/GATE/K-SET/UGC/M-Phi through Entrance Exam are exempted from this condition.
- 5) Examination fee has to be paid to the Examination Account of the University and the Challan has to be furnished at the time of submission of the Final Synopsis and Thesis.
- 6) While submitting the progress report Tuition & Processing Fee has to be paid to the Examination Account and the Challan Should be enclosed.
- 7) On completion of research work 15 copies of synopsis, 5 copies of thesis, an electronic version of the thesis, evidence of two research publications, prescribed application form for submission of thesis/synopsis, challan for having paid the examination fee, declaration signed by the candidate and certified by the guide for having prepared the thesis, No. Due Certificates from the department, Library and the hostel should be submitted through the guide and through the head of the Department/Institution. Details of fee can be had from the Registrar's office.
- 8) If you fail to submit the thesis even after 7 years i.e after getting 2 years extension of time, the registration will become invalid automatically.
