



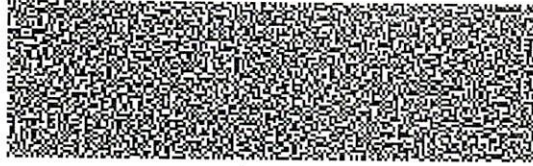

Whereas the above-named institutions recognize that Knowledge Partner and Academic collaboration would be of mutual benefit and would provide strengths in Research and education and their mutual interest in engaging themselves in cooperation with the Radio Manasa 89.6 FM, Community Radio Station, University of Mysore, Mysuru and the All India Institute of Speech and Hearing (AIISH) is the Collaborating institute(s), it is agreed that:

This agreement witnesses as here under:

POINT 1: SPECIFIC PURPOSE OF AGREEMENT

The parties agree to cooperate in the following areas: -

1.1 Knowledge Partnership

- a. AIISH will act as the Knowledge Support and Academic collaborator to help for e-content Preparation, Delivery and Development and Recording of Audio for the purpose of Radio transmission activity shall have a focus on communication disorders, their clinical assessment and rehabilitation aspects covering diagnostics, therapeutics, and rehabilitation etc.
- b. Each collaborative activity shall be significant from both scientific as well as societal benefit points of view.


1.2 Development of e-content in the form of Audio Modules

AIISH Faculty members will engage for e-content Preparation, Delivery and Development and the Radio Manasa 89.6 FM, Community Radio Station, UoM will record and edit for the purpose of Radio Broadcasting and Transmission in line with the Community Radio Station Guidelines issued by the Ministry of Information and Broadcasting, Government of India, New Delhi.

1.3 Needs-based Academic Collaboration

Based on mutual need, Institutions shall explore additional ways of collaborating to help strengthen the research and developmental activities related to e-content preparation, delivery and development. The activities may include joint discussion, workshops and seminars for the purpose of e-content preparation and development. The details of above activities and arrangements shall be negotiated at the appropriate time on a case-to-case basis and be governed by the relevant approval processes of both the Institutions.

POINT 2: RESPONSIBILITIES

Both institutions acknowledge the mutual alignment of their institutional vision, mission and values. Both organizations commit themselves to jointly accomplish the goals of the e-content preparation and development for the purpose of Radio Broadcasting and Transmission.

- 2.1 Sharing of information:** The Radio Manasa 89.6 FM, Community Radio Station shall have right of produced audio contents for the purpose of Radio Broadcasting and Transmission. Both institutions shall maintain their respective lawful status with the appropriate authorities for the duration of the Agreement. Either institutions shall keep the other informed of any change whatsoever occurring in the engagement plan which may affect the timely delivery of services and accomplishments.
- 2.2 Financial support:** At this point this initiative is without financial implications of both Institutions. However, for long-term viability and sustainability of the e-contents preparation and development, both Institutions agree to explore and identify respective funding opportunities with mutual consent.
- 2.3 Focal Person(s):** Coordinator, Radio Manasa 89.6 FM, Community Radio Station, University of Mysore, Mysuru and Assistant Professor in Speech Pathology, Department of Speech Language Pathology from All India Institute of Speech and Hearing (AIISH) is designated focal person(s) to provide support to the tasks, whose duties include supporting the activities for the smooth implementation.

POINT 3: LANGUAGE

All written correspondence and activities relating to the tasks shall be transacted in the Kannada and English Languages.


POINT 4: FORCE MAJEURE

No Institution covered under this agreement shall be liable for any failure to perform its obligation where such failure is a result of Acts of God, which are here defined as force majeure.

POINT 5: DURATION AND TERMINATION

This AGREEMENT shall come into effect on the date of signature by the two Institutions and shall remain in force for an initial period of two (2) years, unless otherwise terminated by mutual consent, and with 30 days prior written notice to the other Institution.

IN WITNESS WHERE OF, the undersigned being duly authorized by their respective Institutions, have signed this MoU.


