1. BA Philosophy Syllabus
2. MA Philosophy syllabus.
3. PG Diploma in Swami Vivekananda Studies Syllabus.
4. Panel of Examiners for MA Philosophy, PG Diploma in Swami Vivekananda Studies and BA Philosophy.

The Board resolved the following –

1. It resolved to approve BA Syllabus for Philosophy for 1st and 2nd Semester for Five Credits each.
 - a. BA 1st Semester: Title of the Paper: History of Indian Philosophy
 - b. BA 2nd Semester: Title of the Paper: History of Western Philosophy
2. It resolved to recommend University to follow the following question paper pattern.
 - a. 20 Marks for Internals (C1 – 10 Marks & C2 – 10 Marks)
 - b. 80 Marks for Semester End Exam (C3 – 80 Marks)

There shall be Three parts in Question Paper for C3 Exam, Part-A, Part-B and Part-C.

- a. In Part-A there shall be 4 questions out of which students will answer any 3 questions. (3 x 15 = 45 Marks)
- b. In Part-B there shall be 3 questions out of which students will answer any 2 questions. (2 x 10 = 20 Marks)
- c. In Part-C there shall be 6 questions out of which students will answer any 5 questions. (5 x 3 = 15 Marks)

3. It also resolved to request the University to give Question Paper Codes for the approved papers.

4. It also resolved to modify the existing Syllabus for MA Philosophy which contains Five Units in each paper shall be reduced to Four Units.

5. It also resolved to retain the existing Syllabus for PG Diploma in Swami Vivekananda Studies.

6. The Board also prepared Panel of Examiners and approved the same and the Chairman is authorized to submit the same to the Registrar (Evaluation) University of Mysore.

The meeting concluded with the expression of gratitude to the Members of the Board by the Chairman.
