Pursuant to the approval of the Hon'ble Vice-Chancellor, Smt.Nandini.D D/o Dharmappa S.K, No.51, Lakshmi Hayagreeva, 7th Cross, Aishwarya Royal Layout, Rajarajeshwari Nagara, Mysuru, Karnataka-570 022, is awarded the National Fellowship for Scheduled Caste in Computer Science and Application on a Fellowship value of Rs.42,000/-per month initially for a period of two years. She shall work on the research topic "ARTIFICIAL INTELLIGENCE IN QUALITY EVALUATION OF FOOD PRODUCTS" under the guidance of Prof.Guru D.S., Professor, Department of Studies in Computer Science, Manasagangothri, Mysuru.

She is entitled to get an Annual Contingency Grant of Rs.12,000/- as per rules in force. She shall utilize this grant with the prior permission from the Chairman, Department of Studies in Computer Science, Manasagangothri, Mysruru and also on the recommendation of the guide seeking permission for the subsequent occasion. Further, as per rules, she is entitled to draw House Rent Allowance at the rate of 18% of the fellowship amount. She should report herself for duty to the Chairman, D.O.S in Computer Science, Manasagangothri, Mysuru within a period of one week from the date of receipt of this order, failing which the award will be treated as cancelled.

The tenure of fellowship is five years, but as per the reference cited (3) above, the candidate has availed SC/ST Fellowship from the University of Mysore for Nine months, hence, the tenure of the fellowship is for four years and three months only.

On completion of two years research, the work of the fellow will be evaluated by experts. If the research work is found satisfactory, her tenure will be extended for a further remaining period under the enhanced emoluments of the Senior Research Fellowship (SRF).

In case, the work for the first two years is not found satisfactory, an additional year will be given to her for improvement. However, during this period she will be designated as a Junior Research Fellow. In such case, work will be evaluated again after three years, and if improvement is found, the Fellow will get remaining period under the SRF. Thus, the total period of fellowship (JRF and SRF) is five years, (counting the period of fellowships obtained from the University of Mysore,) and there will be no further provision for extension.

* The fellowship will be effective from 13-04-2023 or date of Joining of Ph.D research whichever is later. She should give a declaration at the time of reporting to duty and the same shall be forwarded to the University.

At the time of joining duty, she is required to produce all the Original Certificates of qualifications, age and date of birth before the Chairman, DOS in Computer Science, University of Mysore, Mysuru, for verification and return.

Award of this National Fellowship for SC is subject to the conditions stipulated in the Comprehensive Ordinance and UGC Guidelines issued from time to time for award of the Research Fellowship.
