Pursuant to the approval of the Vice-Chancellor, Mr. Jayachandran H.P S/o H. Kempaiah, Chowdeshwari Temple Street, Ikkadahalli Village, Kollegal Taluk, Chamarajanagar District-Karnataka is awarded the National Fellowship for Persons with Disabilities (NFPwD) of SC student for the year 2021-22 in History, The National Fellowship for Persons with Disabilities (NFPwD) is tenable for five years subject to the satisfactory progress report of the fellow. He is eligible to draw Rs. 31,000/- per month for first two years and Rs. 35,000/- per month for next three years. He shall work on the research topic "ITTEHAD-UL-MUSALMEEN, 1927-1948: CHARITRE, SIDDANTHA MATTHU CHALAVALI (NIZAM KARNATAKAVANNU ANULAKSHISI)" under the guidance of Dr. Y.H. Nayakwadi, Professor, DOS in History, Manasagangotri, Mysuru.

He is entitled to an Annual Contingency Grant of **Rs.10,000/-** per annum for initial two years, and **Rs. 20,500/-** per annum for remaining three years as per rules in force. He shall utilize the grant with the prior permission from the **Chairman, DOS in History, Manasagangotri, Mysuru** and also on the recommendation of the guide on each occasion and he shall furnish the details of amounts drawn during previous occasions while seeking permission for the subsequent occasion, Further as per rules, he entitled to draw House Rent Allowance at the rate of 18% of the fellowship amount.

He should report himself for duty to the Chairman, DOS in History, Manasagangotri, Mysuru within a period of one week from the date of receipt of this order, failing which the award will be treated as cancelled and disposed of otherwise. The fellowship will be effect from 2020-21 or from the date of registration under Ph.D. or from the date of joining in Ph.D. Programme, whichever is later.

The fellowship is tenable for five years subject to satisfactory progress report of the fellow or submission of Ph.D. thesis whichever is earlier. He should give a declaration at the time of reporting to duty and the same shall be forwarded to the University.

At the time of joining duty, he is required to produce all the original certificates of qualifications, age and date of birth before **Chairman**, **DOS** in **History**, **Manasagangotri**, **Iysuru** for verification and return. And Award of the National Fellowship for Persons with Disabilities (NFPwD) is subject to the conditions stipulated in the Comprehensive Ordinance and Department of Empowerment of Person with Disabilities (Divyangjan) guidelines issued from time to time for award of the National Fellowship for Persons with Disabilities (NFPwD).

2. The Ph.D registration is valid for a period of 6 years from the date of provisional registration and it is extendable by one more year on request by the candidate well in advance with a recommendation of the Guide and Director/Chairperson of the Institute/Department followed by approval of Vice-Chancellor on payment of the prescribed fee.

3. The candidate should submit progress reports certified by the Guide and Director/Chairperson of the Institute/ Department with the fee paid challan in every year. If the candidate fails to submit two Consecutive Progress Reports in time, it amounts to cancellation of the Registration, and this shall be notified by the Registrar (Evaluation). For any reason the fee paid, will not be reimbursed to the researcher.

4. While submitting the progress report Tuition fee, Processing fee and Laboratory fee has to be paid to the Examination Account and the Challan should be enclosed.

5. Examination fee has to be paid to the Examination Account of the University and the Challan has to be furnished at the time of submission of Final Synopsis and Thesis.

6. The Research candidate shall strictly adhere to the Regulation mentioned above.

- 7. On completion of research work, 10 copies of synopsis and 4 copies of thesis, an Electronics version of the thesis, evidence of two research publications, prescribed application form for submission of thesis and synopsis, challan for having paid the examination fee, declaration signed by the candidate and certified by the guide for having prepared the thesis, No Due Certificates from the Department, Library and the Hostel should be submitted through the guide and the Director/Chairperson of the Institution/Department. - 2. Fellowships shall be awarded to candidates for pursuing regular and full time M.Phil./Ph.D courses in Universities/Research Institutions recognized by UGC. After two years of joining JRF, if the progress in the research work of the awardee is found satisfactory, his/her tenure will be extended for a further period of three years as Senior Research Fellowship (SRF) as per UGC Fellowship Guidelines issued from to time, in case of students enrolled for Ph.D or M.Phil.+Ph.D.
- 3. Fellowship commences w.e.f. 01.04/2021 or from the date of Registration under M.Phil. / Ph.D. or from the date of Joining M.Phil. /Ph.D. programme, whichever is later.

5. The candidate must get himself/herself registered for M.Phil/Ph.D at the first available opportunity but not later than within a period of two years from the receipt of award letter and this period is not extendable. However, the actual payment of fellowship will be made with effect from date of issuance of JBF award letter under NFPwD or date of joining of the M.Phil/Ph.D., whichever is later.

- 6. It may be noted that the fellowship amount shell be disbursed through Scheduled Bank to the bank account of the awardee (any bank). The awardee is required to submit a copy of the Award Letter, Joining Report, Photograph, address and contact no. In the prescribed proforma Annexure I to the concerned Nodal Officer of his/her University/Institute, who will verify and upload the same accompanied with Certificate in the prescribed proforma Annexure II to scholarship web-portal.
- 7. The awarded is also required to upload the following documents to the designated scholarship webportal through the concerned Nodal Officer of his/her University/Institute at stipulated time interval:
 - At the end of every three months a 'Continuation Certificate' in the prescribed proforms Annexure
 — III, which will make the awardee eligible to draw the fellowship for the next three months.
 - Half yearly submission of Progress report in the prescribed proforms Annexure IV along with the 'Continuation Certificate'.
 - Details of the expenditure incurred out of the contingency grant and the utilisation certificate to be submitted enqually in the prescribed proforms Annexure — V.
 - d. The claim towards HRA is subject to the submission of HRA certificate in the prescribed proforma Annexure—VI.
 - e. After the completion of two years of award of fellowship 'Upgradation Certificate' need to be submitted in the prescribed proforma America VII, with the Progress Report and Continuation Certificate.
- 8. It may please be noted that the award is flable to be cancelled and it will also attract legal action against the awardee in the following cases:
 - I, if the awardee is found to be ineligible to receive the award, at any point of time during the entire duration of the fellowship.
