The National Fellowship for SC is tenable for five years subject to the satisfactory progress report of the fellow. He is eligible to draw Rs. 31,000/- per month for first two years and Rs. 35,000/- per month for next three years. He shall work on the research topic "IMPACT OF WORLD WARS **UPON THE COMMON PEOPLES IN PRINCELY STATE OF MYSORE**" under the guidance of **Dr.** K. Sadashiva, Professor, DOS in History, Manasagangotri, Mysuru, He is entitled to an Annual Contingency Grant of Rs. 10,000/- per annum for initial two years and Rs. 20.500/- per annum for remaining three years as per rules in force. He shall utilize the grant with the prior permission from the Chairman, DOS in History, Manasagangotri, Mysuru and also on the recommendation of the guide on each occasion and he shall furnish the details of amounts drawn during previous occasions while seeking permission for the subsequent occasion. Further as per rules he entitled to draw House Rent Allowance at the rate of 16% of the fellowship amount.

He should report himself for duty to the Chairman, DOS in History, Manasagangotri, Mysuru within a period of one week from the date of receipt of this order, failing which the award will be treated as cancelled and disposed of otherwise. The fellowship will be effect from 05.11.2022 or from the date of admission under Ph.D. or from the date of joining Ph.D. Programme, whichever is later.

The fellowship is tenable for five years subject to satisfactory progress report of the fellow or submission of Ph.D. thesis whichever is earlier,

He should give a declaration at the time of reporting to duty and the same shall be forwarded to the University.
