Pursuant to the approval of the Hon'ble Vice-Chancellor, Mr. Ramaraddeppa S/o Amaregouda, Gonawatla Village and Post, Lingasguru Taluk, Raichur District Karnataka is awarded the UGC JRF in Kannada on a Village and value of Rs.37,000/- per month initially for a period of two years. He shall work on the research topic Fellowsinp ರಾಜ್ಯ ಕಟ್ಟೆಯ ತತ್ವಪದಕಾರರ ಒಂದು ಅಧ್ಯಯನ under the guidance of Prof. Vijayakumari S Karikal, Professor, Kuvempu Institute of Kannada Studies, Manasagangotri, Mysore.

He is entitled to get an Annual Contingency Grant of Rs.10,000/- as per rules in force. He shall utilize this grant with the prior permission from the Director, Kuvempu Institute of Kannada Studies, Manasagangotri, Mysore grant with the recommendation of the guide seeking permission for the subsequent occasion. Further, as per rules, he is entitled to draw House Rent Allowance subject to production of relevant documents as per the UGC norms. He should report himself for duty to the Director, Kuvempu Institute of Kannada Studies, Manasagangotri, Mysuru.

The tenure of fellowship is initially for two years under the JRF scheme. Upon expiry of this period, the work of the fellow will be evaluated by experts. If the research work is found satisfactory, his tenure will be extended for a further period of three years under the enhanced emoluments of the Senior Research Fellowship (SRF).

In case, the work for the first two years is not found satisfactory, an additional year will be given to him for improvement. However, during this period he will be designated as a Junior Research Fellow. In such case work will be evaluated again after three years, and if improvement is found, the Fellow will get two more years under the SRF. Thus, the total period of fellowship (JRF and SRF) is five years, and there will be no further provision for extension.

The fellowship will be effective from 13-10-2023 or date of Joining of Ph.D research whichever is later. He

should give a declaration at the time of reporting to duty and the same shall be forwarded to the University.

At the time of joining duty, he is required to produce all the Original Certificates of qualifications, age and date

of birth before the Director, Kuvempu Institute of Kannada Studies, Manasagangotri, Mysore. Award of this UGC Junior Research Fellowship is subject to the conditions stipulated in the Comprehensive Ordinance and UGC Guidelines issued from time to time for award of the Research Fellowship.
