Pursuant to the approval of the Hon'ble Vice-Chancellor, Mr. Darshan D. s/o 6 Doddamadaiah, Hooradahalli, Mudgur Post, Gundlupet Taluk, Chamarajanagara District- 571 123, Karnataka, is awarded the National Fellowship for SC Candidate UGC NET-NFSC for the year 2023-24 in Mathematical Sciences. The National Fellowship for SC is tenable for five years subject to the satisfactory progress report of the fellow. He is eligible to draw Rs. 37,000/- per month for first two years and Rs. 42,000/- per month for next three years. He shall work on the research topic "CERTAIN INVESTIGATION IN RAMANUJAN'S NOTEBOOK RELATED TO THETA FUNCTIONS" the guidance of Prof. Vasuki, Professor, DOS in Mathematic, Manasagangotri, University of

He is entitled to an Annual Contingency Grant of Rs. 12,000/- per annum for initial Mysore, Mysore two years and Rs. 25,000/- per annum for remaining three years as per rules in force. He shall utilize the grant with the prior permission from the Chairman, DOS in Mathematic, Manasagangotri Mysuru and also on the recommendation of the guide seeking permission for the subsequent occasion. Further, as per rules, he is entitled to draw House Rent Allowance at the rate of 18% by producing relevant documents as per UGC norms. He should report himself for duty to the Chairman, DOS in Mathematic, Manasagangotri Mysuru University of Mysore, Mysuru

The tenure of fellowship is initially for two years under the JRF scheme. Upon expiry of this period, the work of the fellow will be evaluated by experts. If the research work is found satisfactory, his tenure will be extended for a further period of three years under the enhanced emoluments of the Senior Research Fellowship (SRF).

In case, the work for the first two years is not found satisfactory, an additional year will be given to him for improvement. However, during this period he will be designated as a Junior Research Fellow. In such case work will be evaluated again after three years, and if improvement is found, the Fellow will get two more years under the SRF. Thus, the total ,2

period of fellowship (JRF and SRF) is five years, and there will be no further provision for extension.

The fellowship will be effective from 25-07-2023 or date of Joining of Ph.D research whichever is later. He should give a declaration at the time of reporting to duty and the same shall be forwarded to the University.

At the time of joining duty, he is required to produce all the Original Certificates of qualifications, age and date of birth before the Chairman, DOS in Mathematic, Manasagangotri Mysuru University of Mysore, Mysuru

Award of this National Fellowship for SC Candidate UGC NET-NFSC is subject to the conditions stipulated in the Comprehensive Ordinance and UGC Guidelines issued from time to time for award of the Research Fellowship.
