Ms. Malligadevi S.N. D/o Nagarajanayaka, #628, Ramamandira Street, Sutturu, Nanjangud Taluk, Mysore District -571 129, Karnataka is awarded the National Fellowship and Scholarship for Higher Education of ST Students for the year 2023-24 in Humanities & Social Sciences. The National Fellowship for Higher Education is tenable for five years subject to the satisfactory progress report of the fellow. She is eligible to draw Rs. 37,000/- First 2 Years and Rs. 42,000/- remaining 3 Years per month. She shall work on the research topic "KARNATAKADALLI SAMANVAYA SAMSKRUTHI AMTTU KOMUVADADA MUKAMUKI: 1991 RA NANTHARADA ONDU ADYAYANA" under the guidance of Prof. Muzaffer H Assadi, Professor, DOS in Political Science, Manasagangotri, University of Mysore, Mysore.

She is entitled to an Annual Contingency Grant of **Rs. 20,500/-** per annum as per rules in force. She shall utilize the grant with the prior permission from the **Chairman, DOS** in **Political Science, Manasagangotri, University of Mysore, Mysore** and also on the recommendation of the guide on each occasion, and she shall furnish the details of amounts drawn during previous occasions while seeking permission for the subsequent occasion. Further as per rules, he entitled to draw House Rent Allowance at the rate of 18% of the fellowship amount.

She should report herself for duty to the Chairman, DOS in Political Science, Manasagangotri, University of Mysore, Mysore within a period of one week from the date of receipt of this order, failing which the award will be treated as cancelled and disposed of otherwise. The fellowship will be effect from 01.04.2023. However, if scholar has joined Ph.D. after 01.04.2023, her fellowship will commence from the

date of joining of Ph.D. Moreover, the payment of fellowship shall be regulated, s per para 5.4.1 of the Guidelines her fellowship end on 30.06.2028

The fellowship is tenable for five years subject to satisfactory progress report of the fellow or submission of Ph.D. thesis whichever is earlier. She should give a declaration at the time of reporting to duty and the same shall be forwarded to the University.

At the time of joining duty, she is required to produce all the original certificates of qualifications, age and date of birth before **Chairman**, **DOS** in **Political Science**, **Manasagangotri**, **University of Mysore**, **Mysore** for verification and return. Award of the National Fellowship and Scholarship for Higher Education of ST student is subject to the conditions stipulated in the Comprehensive Ordinance and Ministry of Tribal affairs guidelines issued from time to time for award of the National Fellowship and Scholarship for Higher Education of ST student.

Regarding payment of fellowship amount the awardee is required to follow the instructions given in the award letter.

The fellowship amount will be paid up to the period of five years or till the date of submission of dissertation, whichever is earlier. Irrespective of the selection year, the course duration will be counted from the date of joining of Ph.D. For those students who already joined the course and got selected for the year 2023-24, the fellowship will commence from 01.04.2023. However, if, scholar has joined Ph.D. after 01.04.2023, his/her fellowship will commence from the date of joining of Ph.D. Moreover, the payment of fellowship shall be regulated, as per para 5.4.1 of the guidelines.

- 3. The provisional selection is subject to the condition that the awardee has already joined regular and full time Ph.D. course in a University/Institution covered under the Scheme Guidelines as mentioned in Para no. 2.4, while applying for the fellowship, and other conditions of the scheme and stipulations mentioned in this letter.
- The awardee is required to produce original certificates including Bank Pass book respective University/Institute for verification and linking at https://scholarship.canarabank.in. The linking process should be completed on or before 30th March 2024 by the concerned university/Institute. Failure to link in the Canara Bank portal before the specified timeline will render this award cancelled. The awardee's Bank Account should be Aadhaar linked, Email id, phone number and Bank Account number of awardees should remain unchanged during the entire period of fellowship.
- 5. The award is liable to be cancelled and appropriate legal action will be taken against the awardee in the following cases: -
