POINT 2: RESPONSIBILITIES

Both institutions acknowledge the mutual alignment of their institutional vision, mission and values. Both organizations commit themselves to jointly accomplish the goals of the content delivery and development for the purpose of Radio Broadcasting and Transmission.

- 2.1 Sharing of information:** The Radio Manasa 89.6FM, Community Radio Station shall have right of produced audio contents for the purpose of Radio Broadcasting and Transmission. POINT 3: LANGUAGE

All written correspondence and activities relating to the tasks shall be transacted in the Kannada and English Languages.

POINT 4: FORCE MAJEURE

No Institution covered under this agreement shall be liable for any failure to perform its obligation where such failure is a result of Acts of God, which are here defined as force majeure.

POINT 5: DURATION AND TERMINATION

This MoU shall come into effect on the date of signature by the two Institutions and shall remain in force for an initial period of two (2) years, unless otherwise terminated by mutual consent, and with 30 days prior written notice to the other Institution.
