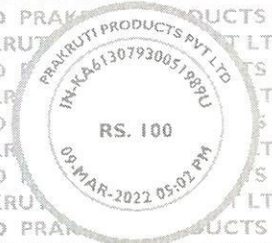
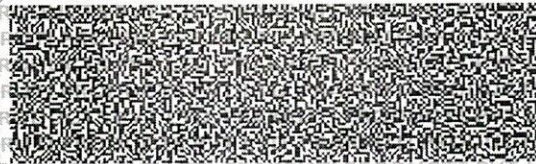

PARTY 1: PRAKRUTI PRODUCTS PVT. PARTY 2: UNIVERSITY OF MYSORE here in after referred as UOM, The UOM was established on July 27, 1916. It is the sixth oldest in the country and the first in the state of Karnataka. Also, in a sense it is the first university of the country to be established outside the limits of the British India. The university was founded as a result of the efforts of the benevolent and visionary Maharaja of erstwhile Princely State of Mysore His Highness Shri Nalvadi Krishnaraja Wadiyar – IV (1884-1940), and the then Diwan Sir M. Visvesvaraya (1860-1962). It was the first University to be accredited by NAAC in 2021 with A Status in Karnataka state

The Department of studies in Chemistry located in the Manasagangotri campus University of Mysore, Mysuru and established in 1960 to provide opportunities for post-graduate studies and Research in Chemistry. In addition to the teaching activities, with 90 students in take, the research activity is also going on in the department. The three new annexes were built, equipped and added to the main building. Analytical Chemistry was introduced as a branch of specialization in 1972. Presently, the department has seven distinguished faculty members engaged in teaching and research programmes.

OBJECTIVES / ACTIVITIES OF THE MOU:

Activities would mean

1. Seek mutual advice and support in planning and executing programs promoting excellence in respective areas of research.
2. Encourage scientist / research personnel of either Institute to attend lectures, seminars, workshops and conferences in the respective areas of interest;
3. Share the library and scientific literature facilities mutually by giving access to library and other resources of either Institute to the scientists / students / research personnel of other Institute;
4. Encourage the research associates / scientist of UOM and scientific staff of Prakruti Products to visit the each other Institutes for short durations for getting research inputs and guidance upon recommendation from the research guides/faculty members of UOM or Directors of Prakruti Products.

5. Each host institute, in the pre visit agreement correspondence will also coordinate support with the visiting institution for office space, library, laboratory and other privilege appropriate to the levels and purpose of the visit subject to the availability of resources.
6. Encourage joint research activities to develop research projects and research facilities by the faculty members / scientific personnel of Prakruti Products and UOM through getting grants from national and international funding agencies.
7. Both parties must agree upon the specific terms of any inter-institution initiative relative to this MOU in written or electronically recorded correspondence prior to the initiation of particular program or activity in order for the said initiative to proceed.
8. Industrial Visits: Regular visits to the Industry will make students to learn the processes and reaction mechanisms of the products. Also they will be experiencing the testing of raw materials, intermediates and products.
9. In-plant training to make the students Technically Sound and Industry –ready
10. Academic Lectures by Scientist/Experts : The Industry will cooperate in arranging experts for lectures and interactions
11. Problem Solving /Patents: The problems that arise in the Industry will be tackled jointly by the department and industry and the Patents will be copyright protected as per the MOU.
12. Studies & Survey: Product survey in the market is done by the students as project for developing and studying modifications.
13. Placements: The industry trained students will get good opportunity and will have a better placement in Industries and MNCs.
14. Internships: Students can take up Internships and get trained and help the Industry in turn to modify and flourish.
15. Establishing Advanced Labs: New equipment's and Instruments will be introduced as the Academic Research Progresses resulting in a State-of-the-art Laboratory.

I. TECHNICAL AREAS OF COLLABORATION:

- a) Provide academic interactions by delivering Special Lectures on topics of relevance to modern Industry and the University.
- b) To facilitate the training for teachers and PG students.
- c) Technicians from Prakruti Products will visit and utilize the Lab Periodically.

II. PROPOSED MODES OF COLLABORATION:

- a) Cooperation and promotion of education and training in areas of mutual interest.

IV. COORDINATORS:

Both Dr. Devaraj Reddy from Prakruti Products and Dr. M.P.Sadashiva, Associate Professor, Department of Studies in Chemistry from University of Mysore will have responsibility for coordinations and implementation of this MOU and the same shall be communicated to the other party.

V. INDEMNITY:

Prakruti Products shall indemnify UOM in nexus with the students received from UOM against any harm, loss, injury, mentally or physically caused to any student or coordinator during the time of visit to Prakruti Products Plant. Prakruti Products shall take all the necessary precautions with regard to the safety and health of the students when they are in Prakruti Products Plant.

VI. INTELLECTUAL PROPERTY, INVENTIONS AND INNOVATIONS

1. The terms with respect to title and exploitation of intellectual property (including) traders and trade marks, copyrights, patent, proure & product designs and confidential information on the subject for such intellectual property, inventions and innovations as a result of joint research and collaborative activity under the MOU will be negotiated on project-by-project basis in the specific research project agreements and broadly governed by the IPR policy of the Parties to the MOU.
2. Information of the research results and scientific material (reports, articles, books) will be exchanged freely keeping in mind the mutually agreed provisions of untactful property soley conceived.
3. The purpose of this MOU the term intectual property shall mean any and all works and property including but not limited to all intellectual properties ideas, inventions, concepts, products improvement, innovations, discoveries, development methods, formulas techniques, software know how and writings made conceived reduced to practice.

VII. CO-ORDINATING COMMITTEE

1. The coordinating committee will be constituted including Directors of Prakruti Products and UOM to oversee the activities mentioned above in Section I. ACTIVITIES. If necessary, two additional members from each institute will be included for the effective implementation of the MOU.
2. If any charges expenses are to be paid by either institute for the facilities provided by the other institute, such will be decided by the co-ordinating committee by a separate rentals and service agreement which also may be modified from time to time as per the need.
